- If you complete secondary education in a foreign country, a copy of the "secondary school leaving certificate" or other similar document.
- An academic transcript that indicates you successfully completed a least a two-year program that is acceptable for full credit toward a bachelor's degree.
- If you were homeschooled from a state where state law required you to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized), a copy of that credential.
- If you were homeschooled from a state where state law does not require you to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), transcript or the equivalent a transcript or the equivalent, signed by your parent or guardian, that lists the secondary school courses you completed and includes a statement that you successfully completed a secondary education in a homeschool setting.
