## RESOLUTION TO CALL BOARD OF REGENTS ELECTION MAY 7, 2022

WHEREAS, the laws of the State of Texas provide that an election for regents for said junior college district shall be held in May in even numbered years and further provide that said election shall be ordered by the Board of Regents

THEREFORE, BE IT ORDERED BY THE BOARD OF REGENTS OF CLARENDON COLLEGE DISTRICT:

That an election be held in said District on the first Saturday in May, the same being the 7th of May, 2022 for the purpose of electing (6) members to the Board of Regents of said junior college district- six (six) members to be elected to fill three full terms positions (expires 2028) at large on said Board of Regents; and two (2) unexpired terms (expires 2024) and one (1) unexpired term (expires 2026).

That said election shall be held at the County Clerk's Office, Donley County Courthouse Annex Building, 220 W. 4<sup>th</sup> Street, P.O. Drawer U, Clarendon, Texas for Precinct #1, Box 01, Precinct #1, Box 02, Precinct #2, Box 01, Precinct #3, Box #01, Precinct #4, Box #01; and Precinct #3, Box #03 at Hedley First Baptist Church Fellowship Hall, Main Street, Hedley, Texas.

The polls at the above designated polling places shall on Election Day be open from 7:00 a.m. to 7:00 p.m.

Vicky Tunnell is hereby appointed Clerk for early voting and LaVerne Pinion is hereby appointed Deputy Clerk for early voting. The early voting for the above designated election shall be held at the County Clerk's Office, Donley County Courthouse Annex Building, 220 W. 4<sup>th</sup>, P.O. Drawer U, Clarendon, Texas 79226 within the boundaries of the above named district and said place of early voting hall remain open for at least 7 hours on each day for early voting which I not a Saturday, a Sunday, or an official State holiday beginning the 12<sup>th</sup> day (April 25, 2022) and continuing through the 4<sup>th</sup> day (May 3, 2022) preceding the date of said election. Said place of voting shall remain open between the hours of 8:00 a.m. – 5:00 p.m. on each day for said early voting. The above described place for early voting is also the clerk's mailing address to which ballot applications and ballots voted by mail may be sent.

Any resident qualified elector of the district may have his or her name placed as a candidate on the official ballot for any of the positions to be filled at said above mentioned election by filing a written statement, not later than 5:00 p.m. on the 78<sup>th</sup> ( February 18, 2022) day before the day of the election. An application may not be filed earlier than the 30<sup>th</sup> day before the date of the filing deadline. All candidates shall be resident qualified voters of the district.

This order shall serve as notice for said election and the Chair of the Board or Regents is hereby authorized and instructed to cause a copy of this combined election order and notice to be published one time in a newspaper or general circulation in the county where this college district is located. Said publication shall not be more than 30 days or less than 10 days before the date of said election.

It is further found and determined that in accordance with the order of the Board of Regents that the Secretary post written notices of the date, place, and subject of this meeting on the bulletin board, located in the Administrative office, a place convenience and readily accessible to the general public and said notice, having been posted, it remain posted continuously for at least 72 hours preceding the scheduled time of said meeting, and in addition the Secretary furnishes a notice to the County Clerk of the County in which most if not all, of this District's public reside, and also give notice by telephone or telegraph to all news media requesting such notice and consenting to pay any and all expenses incurred by District in providing special notice.
