\$ _____ Federal Direct Loans are certified for the amount of requested or eligibility, whichever is less. Loans are to be used for Clarendon College students enrolled for educational related expenses only.

I understand, for a Subsidized Loan the government will pay my interest while I am in school, during the grace period before repayment begins, and during any authorized period of deferments. I also understand, once I enter repayment status, I am responsible for the interest on a Subsidized Loan. **NOTE:** Federal regulations limit how much Subsidized Loans can be received per program.

I understand, I am responsible for the interest on any Unsubsidized Loan during in-school status, grace period before repayment begins, and any periods of authorized deferments.

I understand, I must be enrolled in at least six eligible hours each semester in order to receive that semester's disbursement. Any additional assistance received may reduce my loan eligibility. Eligibility for loan funds will be verified prior to each disbursement and could result in the reduction or cancellation of my loan.

My signature certifies that I am the person requesting the above change to my loan funds from the William D. Ford Federal Direct Loan program. I understand that Clarendon College will certify my loan for the amount requested or the amount I am eligible to receive. I further understand, if I choose Subsidized Loans only, **this increase may be denied if I do not have eligibility for that loan program.**
