

# JUNE 8-10, 2021 WASTEWATER COLLECTION (0080)

Wastewater Collection is a comprehensive course that includes a brief review of the water cycle together with a general description of the responsibilities of wastewater personnel and the need for regulations of the wastewater dischargers to protect receiving streams and the public health, safety and welfare. Texas' rules and regulations of certification of wastewater system operators are included.

A brief review of the general goals of wastewater collection and treatment objectives of state and federal regulations and requirements; and the source and general characteristics of wastewater; followed by an in-depth study of the design, materials of construction, and construction practices for wastewater collection systems, lift stations, and force mains; maintenance and operation of collection systems; industrial waste monitoring and control; attendant hazards and general safety practices; and collection system management. Math skills are reviewed and applied to specific problems.

### Acknowledgement of Notice of Potential Ineligibility for License

By signing this form, I acknowledge that Texas Rural Water Association notified me of the following:

- the potential ineligibility of an individual who has been convicted of an offense to be issued an
  occupational license by the Texas Commission on Environmental Quality (TCEQ) upon completion
  of the educational program;
- the current TCEQ Criminal Conviction Guidelines for Occupational Licensing, which describes the process by which the TCEQ's Executive Director determines whether a criminal conviction:
- renders a prospective applicant an unsuitable candidate for an occupational license;
- warrants the denial of a renewal application for an existing license; or
- warrants revocation or suspension of a license previously granted.
- the right to request a criminal history evaluation from the TCEQ under Texas Occupations Code Section 53.102; and
- that the TCEQ may consider an individual to have been convicted of an offense for the purpose of denying, suspending or revoking a license under circumstances described in Title 30 Texas Administrative Code Section 30.33.
